The Christmas Party was discussed with the board agreeing on a 50/50 raffle, \$10 Staples gift card and a 32 GB Memory Stick as prizes.


Micky moved, Carole seconded the meeting be adjourned.



Microsoft's Varied Word-Processing Options


When we hear "word-processing," most of us think of Microsoft Word. A key application in the Office Suite, Word has the greatest number of features (sometimes more than we want) and is the most popular word-processing program in the world. But Word isn't the only word-processing program that Microsoft offers, and some of the others are free.


Figure 1 - WordPad Command Ribbon

WordPad (.rtf), for example, has been included free with Windows since Windows 95. In Windows 10, it isn't in the apps list; you can only find it by typing "WordPad" in the search box on the Desktop. It is a stripped-down version of Word, but with enough features to complete most standard tasks, as shown in its command ribbon (Fig 1). Its file type, rich text format (.rtf), is readable by almost any word-processing program.

NotePad (.txt), another long time free feature of Windows, is even more basic. It removes all formatting from the text, leaving no colors nor fancy text effects, just a few fonts and font sizes, bold and italics. (Fig 2) It is perfect for adding text to web pages or **creating and** editing text files. It too must be searched for in Windows 10.




In 2003, **OneNote** (one) became part of the Microsoft Office suite and has been upgraded twice since. This application is available for the computer or as a mobile app for smartphones and tablets. OneNote gives you a simple way to organize your ideas or schedules. It is advertised as a note-taking app for college students and a way to organize events. It lets you create tabs for each aspect of your activity and pages inside each tab. Plus, you can import photos, maps, schedules, and web pages to keep the details handy, as I did for a trip a few years ago. (Fig 3)

If you make To Do lists, as I do, you'll love **Sticky Notes**. It has been a free feature of Windows since Windows 7. You can search for it or find it in the app list. When you click the app, it puts a yellow post-it type note on the screen. Other colors are available. If your computer has a touch screen, you can write on the Sticky Note with a stylus or your finger. If not, you can type your note. Notes can be resized or moved, as you would any digital object. To get a new Sticky Note, click the + sign. (Fig 4)





In Windows 10, if your note is an appointment reminder with a date and time, Cortana, the voice-activated assistant, can be set to remind you verbally prior to your appointment. If you add a street address, clicking "View Address" will show a map of the location.

Minimize your notes by clicking the Sticky Notes icon on the taskbar. Click again to make them reappear in whatever screen you are viewing. To remove a note, click the trash bin icon on the top right corner of the note. If you use the Sticky Notes app often, you can make it handy by right-clicking the app icon and choosing "Pin to Start." Whether you are an author or a list-maker, Windows has a word-processing app for you.

Don't Get Ripped Off When You Sell Jewelry

You see ads everywhere from dealers and individuals who want to buy your old rings and other expensive jewelry.

What do they know that you don't? Mainly, they know the true value and, if they're unscrupulous, will try to trick you into accepting a low-ball offer.

They're the experts and you're not, right?

In fact, there's a lot you can do to balance the odds and avoid getting scammed.

For instance, Jewelers of America (JoA), a sort of trade association representing about 8,000 jewelers in the United States, says one of the most important things you can do is to avoid acting on impulse.

You may be in dire need of that cash when you see a promising ad in your local newspaper. But you should always weigh up the emotional value of items you're thinking of selling before deciding whether to go ahead — and then take steps to find out what they're worth.

Once you know what you want to sell, it's crucial to get an independent valuation, ideally from someone who isn't planning to buy it. This is especially important if the buyer you're planning to work with is one of those who pay by the value of the weight of gold content.

In some cases, that's the wrong way to sell your gold.

"Designer or antique jewelry could be worth more to sell as a finished piece than for its gold metal," the organization says. Even if it's just a contemporary gold piece, you need to know the purity of the metal, which is one of the most significant factors affecting its value. Is it 10, 14 or 18 karat gold, or maybe even higher?

Look for a quality mark on the piece – showing the karat number followed by a "k." If it's a European piece, it should be stamped with one of the following numbers: 417 (for 10k gold), 585 (14k), 750 (18k) and 999 (24k). If the piece is stamped "GP" it means it's only gold-plated.

The Value of an Appraisal

An appraisal itself can be quite a complex affair and you still have to beware of ill-informed or crooked dealers. Watch out too for unscrupulous appraisers who offer to over-value items in a written appraisal — that's illegal in the United States.

The best approach is to find a local member of the National Association of Jewelry Appraisers. JoA also has a comprehensive guide to the entire appraisals process: Guide to Jewelry Appraisals.

You likely will have to pay for a valuation fee — a charge based on an hourly rate of \$200 is normal — but this could still earn you a lot more money in the long run when you come to sell.

In a recent *Washington Post* report, an appraiser recalled a customer bringing in a sapphire ring previously valued at \$18,000 — valuable enough you might think — that he subsequently appraised at almost half a million dollars because of certain rare characteristics.

In another test, the *Post* received wildly different offers for the same ring, some of them pure rip-offs.

An appraisal, of course, won't tell you how much you'll get but it will give you a benchmark to test the integrity of anyone you're thinking of selling to.

Once you're satisfied you know what you're selling and, if (Continued on page 8)

it's a high value piece, you have a written appraisal, you need to find a reputable buyer, such as one that's a JoA member.

Check the name online of anyone you're considering selling to. You'll soon discover if they are less than reputable.

It's best to shop around and get two or three offers too. You may be surprised to find that even among legitimate buyers, prices can vary according to their own valuations and priorities

JoA also warns that before you leave an item with a potential buyer, be sure you've checked them out and that you have photos and documentation relating to the pieces you're disposing of.

And find out what the company's or individual's reimbursement policy is in the event that a piece is lost.

Online Dangers

That raises another issue — the danger of sending your gold jewelry to an online buyer. If they're not established and reputable, they may not only pitch a low offer but, in a worst-case scenario, you may never see it again.

Once more, it's important to check the reputation of an online dealer. Also, be sure to check their terms and conditions. For instance, the small print might say that if you don't respond to their offer within, say, 10 business days, it's considered a done deal and they'll send you a check instead.

By the way, if you're a buyer rather than a seller, watch out for scammers trying to offload imitation gold and other poor value jewelry items.

A lot of negative, and often misleading, publicity concerning home DNA testing has been floating around the news services this week. In an effort to clear the air, Family Tree DNA has issued the following statement:

HOUSTON, Nov. 28, 2017 /PRNewswire/ — Family Tree DNA (FTDNA), a division of Gene-by-Gene Ltd, the first to market with a consumer oriented genealogical DNA testing kit and the only genealogical DNA testing company with its own state-of-the-art genetics laboratory, is telling consumers they will never sell their genetic data in a consumer awareness campaign entitled "Can the Other Guys Say That?"

"We feel the only person that should have your DNA is you," says Bennett Greenspan, President and Founder of Family Tree DNA. "We don't believe it should be sold, traded,

or bartered."

According to Greenspan, "the value of DNA testing is that the DNA test can tell you things about yourself that you cannot determine by looking in the mirror. It allows you to interrogate the history book written in your cells."

The media campaign comes at the start of what is traditionally the biggest selling season of the year for genealogically focused DNA testing companies, reminding consumers who flock to genealogical sites to purchase their holiday gifts that, "Finding your roots is fun, but not all DNA test companies are created equal."

Other DNA testing companies are, in fact, selling consumers' genetic data to pharmaceutical companies for a profit. While these companies claim to remove personally identifying information prior to selling the data, the question, says Greenspan, is whether consumers feel the sale of their genetic data is "part of the deal [they] really thought [they] were signing up for when [they] ordered a simple DNA test for genealogical purposes."

The "Can the Other Guys Say That?" campaign launched on Thanksgiving Day and encourages consumers to "Make the Smart Choice this Holiday Season."

Chromebooks for Seniors

Chromebooks are laptops that use Google's operating system. They are quite inexpensive as compared to a Windows or Apple machine. My newest Chromebook is 15" and was \$129.00 as a refurbished item.

I had a back injury some years ago when I heard about Chromebooks as they had just been rolled out. The critics slammed them as being guite useless. I seemed to be drawn to them after reading a lot about how they work. This looked like a good computer to me. I decided to challenge the critics and make this my main machine if I could. I would be able to spend some time learning as I was laid up.

One drawback that the critics named was storage. My first Chromebook had only 18gb of hard drive. I had a Gmail account and found that I had 15gb of space for free. I could also add an SD card to give me much more. Also, when you buy a Chromebook you get an extra 100gb of online storage for free for a couple of years. Another, or maybe equal to the first was that you had to be online to use your Chromebook. I always am so that didn't bother me. Improvements have made the Chromebook useful offline as of now. The third obstacle was that you couldn't load software.

True, but instead we use apps that are downloaded. In my opinion, they are better than software. Some of the apps are not as robust as a complete software suite. But, hey, I have slowed down with work and the apps work fine for me. Also, Google sets up a drive in the cloud, which means on their servers, for the user. Included is a software suite almost as good as Microsoft Office and compatible with it.

Once I got the knack of using my Chromebook I never looked back. Updates take a few seconds. The laptop starts in 7 seconds. The battery life is about 10 hours. I can watch Netflix movies, Skype, Email, create documents and slideshows, and much more. There is no need for antivirus software.

It is perfect for me. Did you know that 70 percent of schools use Chromebooks because of their price and functionality eclipsing iPads and Windows machines for students? So, the critics were dead wrong. They didn't give something new a fair chance. A couple of years ago my grandson, 14, told me how cool my Chromebook was. I sure was proud of my decision to go with my gut and try something new.


