



## Millions of Fake Listings Found on Google Maps

Why defeating and removing scammers is an ongoing problem for Google Maps: Internet Scambusters #879

Google Maps (and other mapping software) have changed our lives for the better and made shopping easier and, often,

cheaper. But not always.

The Internet search giant recently confirmed that it has removed 11 million fake listings from its mapping software but added that the scam is an ongoing problem.

In this week's issue, we'll explain what's happened, and how businesses and consumers can avoid the tricksters.

Let's get started...

When you're looking for a local store, restaurant, contractor or other business to visit, do you turn to Google Maps?

If so, you need to know that, while the locations might be accurate, some of the listings may not be.

According to new research, there are (or were, depending on whether Google has sorted it out or not) millions of fake business listings. In fact, a recent *Wall Street Journal* (WSJ) report claimed there were as many as 11 million fakes!

Google was swift to react when the WSJ reported the issue, removing the identified fakes, but that doesn't mean more won't appear since it's next to impossible to identify the fakes until they're online.

Past experience suggests their internal systems are able to flag 90% of phonies, but the remaining 10% of 11 million would leave a sizeable number (1.1 million) undetected until they're online and identified.

Ethan Russell, Director of Product, explained in a subsequent blog post: "We get millions of contributions each day (like new business profiles, reviews, star ratings, and more) and the vast majority of these contributions are helpful and accurate. But occasionally, business scammers take advantage of local listings to make a profit.

"They do things like charge business owners for services that are actually free, defraud customers by posing as real businesses, and impersonate real businesses to secure leads and then sell them."

Another motive identified by the newspaper was to try to inflict damage on legitimate businesses. For example, disreputable businesses would list the names of their competitors but give the wrong telephone number or address.

Or, they might actually use the name of a genuine business but direct potential customers to themselves, where they proceed to do a bad job and overcharge. This is an ongoing challenge for the Internet giant. Tech site Engadget reports that last year, the firm took down 3 million phony listings and disabled 150,000 accounts.

"We know that a small minority will continue trying to scam others," Russell added, "so there will always be work to do, and we're committed to keep doing better."

#### What To Do

So, how can you protect yourself from future scams?

For businesses, the key defense is to list your own business before anyone else does. It's currently free.

When you're listed, you can go through the <u>Google Maps verification process</u>, which signals to consumers that your business has been verified by the mapping and search outfit.

Until you've done this, says Google, you can't edit the information that's currently there, whether you or someone else posted it.

Verification also makes businesses twice as likely to be considered by reputable users, the firm says.

Verification involves requesting, receiving, and reading a confirmation postcard from Google, though it's also possible to get verification by phone, email, or SMS text.

Whatever method is used, the information you receive will contain a code that has to be keyed in to confirm your address when you sign into Google.

#### **Policies and Tools**

Russell explained: "Although it's important that we make it easy for legitimate businesses to get their business profiles on Google, we've also implemented strict policies and created tools that enable people to flag these issues so we can take action.

"It's a constant balancing act, and we're continually working on new and better ways to fight these scams using a variety of ever-evolving manual and automated systems."

But he was reluctant to share too many details about these efforts to avoid running into the chance they might actually help scammers find new ways to game their systems.

The firm has a dedicated team to tackle the scammers and remove listings that violate its policies. And it's introduced a new and more effective way to report suspicious listings.

It has also published <u>guidelines</u> on the best way for legitimate firms to represent their businesses.

For consumers, the most important step you can take to protect yourself is to be aware of the possibility that, although unlikely, a listing that interests you could be a fake. So, before contacting the business, do a quick search on their name online and make sure it lines up with the map listing.

If you suspect a Google Maps listing may be a fake or you fall victim to a scam as a result, you can complete a <u>redressal complaint form</u>.

## What are the Internet's Rules about Free Speech?



Often, when people find their posts or comments removed or altered from websites they visit, they're quick to claim their right to

free speech has been violated. That's rarely the case.

Can you advise me on the "rules" of the internet regarding free speech? I've had comments on some sites and posts on a discussion group deleted by the owner. Doesn't that violate my right to free speech?

No, it doesn't. Not even close.

Free speech is an interesting concept in general, especially in turbulent times. Take it to the internet, and things get even more "interesting".

Yes, there are rules, and even laws, but it's an incredibly complex issue.

#### My big fat caveat

I am not a lawyer. This is in no way a substitute for legal advice from an attorney or other source better versed in all the nuances of free speech. If you need real, honest legal advice, then get a real, honest attorney.

My discussion here represents only my understanding of and opinions on the assortment of issues related to free speech.

I could be wrong. I don't think I am, but I could be. (Which, by the way, applies to everything I've ever said or published. ①)

#### The internet

Let's start by acknowledging that there is no such entity as "the internet". *Internet* is just a term that describes a vast global <u>network</u> of interconnected computers.

Even the protocols, formats, and various ways devices interconnect aren't governed by enforceable laws. A more appropriate (if sexist) term would be "gentlemen's agreements." Adhere to this specific <u>protocol</u> and you'll be able to do X on the internet. Change that protocol (which can be done) and X

won't work.

Just look at all the cross-browser capability standards to display a webpage and you'll get an idea of those agreements at work. Or not.

#### But there are laws

There *are* laws that govern aspects of how we communicate with each other, including how we do so over the internet.

One problem is that those laws are not global in nature. In reality, they're different for each of the hundreds of countries in which internet users live.

As you might imagine, countries rarely agree on everything, and exactly what you're allowed to say is one of the ways they vary. In some countries, it's illegal to speak ill of the ruling monarch. In others, it's only illegal if you threaten them. In still others, you can pretty much say what you want.

The issues, concepts, and legalities surrounding the internet and what can be done on it are no different. Some countries try to strictly regulate the internet used within their borders; others, not so much. Many try to apply laws that were written before the internet's existence to current internet-

#### **How to Clean Your Dirty Laptop**

After being used regularly for months or years, our laptops accumulate dust, grime, skin oils, sneezes, and who knows what else. Your laptop is most likely due for a cleaning, and I'm going to pass along some suggestions on how to do it effectively without harming

this delicate piece of equipment.

You know your laptop is filthy. You can see the dirt and grime on your keyboard. You might also be able to see grime accumulated on your trackpad. So, it's time for a cleaning.

A shining newly cleaned laptop is a joy to use; the keys are clean; the screen is free of smudges and splatters. These cleaning suggestions might also be useful if you buy a used laptop, since the previous owner doesn't always leave them in pristine condition.

#### Your Supplies

You don't need much to clean a computer; rubbing alcohol, a mild dish detergent, soft lint-free cloths (microfiber cloths are ideal), Qtips, and canned air. Ninety percent or higher isopropyl alcohol is what you want, since it won't damage the internal components. And if you have some particularly



embedded dirt, a Mr. Clean Magic Eraser (or other melamine sponge) can also work wonders, though it should be an absolute last resort since it's abrasive and can leave permanent scratches.

Don't waste your money on specialty cleaners you see at big box electronics stores like Best Buy. They work just fine but no better than what you have at home.

#### Start With the Inside

Starting with that dirt on the keyboard and screen might be tempting, but you should start with the internals. Canned air will blow dust and dirt everywhere, so if you started by cleaning the screen, you'll just end up having to clean it again after you've used canned air. Start by blowing out the dust, then move on to the outside.

You shouldn't have to open your laptop to clean the inside. Turn off the laptop, unplug the power cable and remove the battery, if it pops out (removable batteries are becoming a thing of the past). Give the canned air a quick burst away from the laptop to get rid of any condensation, and then start blowing air into any cracks and crevices: the keyboard, the vents and even

the USB and other ports. Blow in short bursts, since longer sprays can cause moisture to accumulate inside your computer. You can also damage the fans by making them spin too fast.



You probably won't see a big change after doing this. The goal is to prevent dust buildup over time, which can cause your laptop to overheat and possibly spontaneously shut down. If you can see dust bunnies in the vents, you've let it go too long without a cleaning. If there is a dust bunny that you see is stuck behind the vent that you can't dislodge by blasting it with compressed air, consult your

user manual on how to open the case. Be sure you remember which screws went where for the reassembly; snap a picture or two of your laptops before opening the case for a reference and be super-organized with the screws as you remove them.

Smokers and pet owners should take special care to clean the inside often, since you're likely to experience much quicker buildup of dust, smoke, hair and other dirt.

#### Wipe Down the Outside



Remember, when cleaning a laptop (or desktop) computer, you want to apply the cleaning product to the tool you're using to clean, never ever directly onto the computer. So, grab your microfiber cloth, pour a little alcohol onto it, wring it out so it

isn't dripping wet, and wipe down the surface. Cotton swabs with alcohol are useful for the keyboard keys and the small spaces between them. (If there are marks that won't come off, you can try rubbing them with a Mr. Clean Magic Eraser or other cleaner very lightly, but again, they're mildly abrasive and this can alter the finish of the surface.)

It may take a few passes to get all that grime off, but once you do, you should notice a dramatic difference. If your laptop is particularly old, you may not be able to get rid of the shine on the keys; some of us may have worn down the top layer of plastic and even the letters on the keys. There's not much you can do about that.

You should be able to wipe fingerprints off your screen with a dry microfiber cloth. If you need some more cleaning power, a slightly damp cloth that has been completely wrung out first, can help. Some manufacturers, including Dell and Lenovo, even say you can use a 50:50 mixture of isopropyl alcohol and water, if need be, to remove really tough dirt. Just avoid household cleaners with harsher chemicals like ammonia or Windex on the screen.



#### Get Rid of Bad Smells

Let's say you have a particularly terrible case of gross laptop, and even after the above steps, your laptop still carries the essence of whatever it has been exposed to. I've seen many laptops that smelled like smoke and getting rid of that is a

challenge or maybe impossible. Cleaning the surface can help, but a lot of those smells may also be inside the computer. For that, you can turn to a natural deodorizer: charcoal. Don't to go digging through your grill for briquettes — cooking charcoal is different from activated charcoal. Activated charcoal is made with much more (micro) surface area to be more absorbent

Another common item will do - kitty litter. Because most kitty litter formulas have activated charcoal in them to neutralize litter box smells, it's a great odor eliminator.

Seal the laptop up in a bag or closable bin with a cup or so of the activated charcoal or litter and leave it for at least 24 to 48 hours. If you don't have a cat, people also had good luck with diaper pail deodorizers, which are neat little packets of charcoal you can throw away when you're done. The longer you leave the computer in the bin, the better.

#### New Database with Photos of WWll Soviet Army Veterans is now Online



If you have Russian ancestors or other relatives, you probably will be interested in this new online resource. The following is an announcement posted to the International Association of Jewish Genealogical Societies (IAJGS) mailing list by Jan Meisels Allen, Chairperson of the IAJGS Public Records

Access Monitoring Committee:

The Ministry of Defense of the Russian Federation is commemorating the 75<sup>th</sup> anniversary of World War II's Allied victory by creating a new database called Memory Road which contains photos of WWII Soviet Army veterans. Currently, there are over 302,000 veterans documented with their personal photos. Each page on veterans has a link to the Memory of the People database which includes the millions of awards given to Soviet Army service people.

Memory Road can be searched by first name, patronymic name (honoring the father usually the middle name such as Ivanovich) or last name. Go to <a href="https://foto.pamyatnaroda.ru/">https://foto.pamyatnaroda.ru/</a>.

Yes, it is in Russian, but if you use Chrome as your browser it will translate it. You can also use Google Translate <a href="https://translate.google.com/">https://translate.google.com/</a> or another translation service such as DeepL <a href="https://www.deepl.com/translator">https://www.deepl.com/translator</a> or go to Steve Morse's website for translating Russian to English <a href="https://stevemorse.org/russian/eng2rus.html">https://stevemorse.org/russian/eng2rus.html</a>.

According to an article in Lost Russian Family blog: https://lostrussianfamily.wordpress.com/2019/10/19/new-wwii-soviet-army-database-gives-faces-to-veterans/ the best way to use the database is:

- •Copy the name in the box on the top right that says найти героя
- •Open each result link in a new window. If you don't, the website requires you to restart the search.
- •Copy and paste all text into one of the translation services mentioned above.

related issues and experience varying degrees of consistency and success.

In short, there's a bucket load of laws that apply to what happens on the internet. Unfortunately, it's a bucket load of inconsistent, incomplete, and often contradictory laws that may or may not apply to any given situation you might encounter, and even then, only if it rises to the level of some government agency's attention.

To the issue at hand: not all countries have free speech provisions.

Just because you live in a country that affords free speech as a right doesn't mean that the service you're using in that country has the same guarantees. Depending on the location of the company, the individual who owns the site, or the hosting company that provides the server space and network connection, there may be no such thing as any kind of free-speech guarantee. Period.

#### Free speech is probably not what you think

Let's say I run a website. © To keep things simple, we'll say that you, I, and the website are all within the United States.

You take issue with something I post on my website, and you say so, using the comment function on that website.

- •I am not required to publish your comment.
- •If I do happen to publish it, I am not required to keep it published.
- •I can choose to edit your comment; in the worst case, I could make it say something other than you intended.

This has nothing to do with your free speech rights. If anything, I expect it has more to do with my rights as the website owner. I am not required to provide you a place for what you want to say, no matter what you say or how you say it.

*But:* you can set up your own website where you take issue with me. I can do nothing about that.

That's what free speech really is, at least to me: the ability to set up your own pulpit and say what you want. It does *not* mean you have the right to use someone else's venue for your message.

And it doesn't make a difference that you can't

reach *my* audience to make your point from *your* site. Freedom of speech does not guarantee an audience. If you get one, fantastic. I have no rights to reach them via your venue, either.

#### That pesky first amendment

One of the things people like to throw around is the first amendment to the United States Constitution, (often in the context of having their first amendment rights violated). Typically, they are incorrect. The amendment starts with the phrase, "Congress shall make no law...". If no law was made, or you weren't arrested, the first amendment doesn't apply. The wonderful webcomic XKCD explains it beautifully.

#### TOS, AUP, and common sense

There's more to this than the whim of the site owner. Many will have thought through what their site is about and what they want it to look like. They may well have set up some rules or guidelines ahead of time.

Most websites publish "Terms of Service" (TOS) about posting information. Be it writing your own <u>blog</u> on a blog-hosting service, making posts in a forum, or leaving comments on an article, by participating, you either explicitly or implicitly agree to abide by those terms.

Don't like the terms? Don't post there. Go somewhere else. Violate the terms? Expect to see your comments, posts, or blog disappear.

It's not your site. If you want to play there, you must play by their rules.

Similarly, if you make use of a hosting service or something similar to set up your own website, service, or blog, you'll likely be faced with an "Acceptable Use Policy", or AUP. As the name implies, when you use someone else's services — even if you're paying for the privilege — you're required to abide by what they consider to be acceptable use of their services.<sup>2</sup>

And regardless of where you post or host and what their rules are, there remain things that are simply wrong to say or do — at least morally, and perhaps legally. The classic example is that it's not within free speech rights to randomly yell "Fire!" in a crowded theater<sup>3</sup>. Where free speech guarantees are available at all, they don't trump the safety of others.

Making your point

"So, if website owners can just randomly delete my comments or posts, how am I supposed to make my point to the people who are there and need to see it?"

You may not be able to. Whether you're on the web or using another form of media, there's nothing about human discourse that guarantees you get to make your point to the people you think need to hear it. There's certainly no legal recourse that I'm aware of.

Except... (and this is where you *really* need to talk to a lawyer) ...

Defamation, slander, and libel are all terms that have very specific legal implications. I won't try to delve into that. But depending on where you are and your specific situation, information on the internet that intentionally lies about or maliciously harms you may be one thing on which you can act. Like I said, get an attorney.

#### It even happens to me

I've been banned from one discussion forum (that I know of).<sup>4</sup> And as unfair as it is, that site owner has every right to do so. In many ways, it really sucks, because it prevents me from communicating with the other users of that site.


But it simply *must* be this way.

Consider the alternative: that I'm somehow able to *force* that site owner to let me back in. If there were a mechanism to let people force their way onto sites that others own and control, that would have a pretty chilling effect on the internet as a whole. In fact, it's likely that sites like Ask Leo! wouldn't exist. Malicious entities would use that ability to their own ends.

As distasteful as it is, the website owner's ability to pick and choose whom he or she allows on their site is also an important form of freedom of speech.

Even if they're wrong.
